## **MINIBUS DRIVER (Casual)**

The Foundation uses the power of the MFC brand to engage with the community to provide opportunities for disadvantaged young people and adults to maximise their potential to achieve.

Middlesbrough FC Foundation is looking for an enthusiastic and flexible mini bus driver who can support with the wide range of Foundation activities that require occasional transportation. The role will support work across the Tees Valley community, including taking participants from our activities to events and sessions. There will also be opportunities to support the East Cleveland Match Day travel, transporting fans to and from East Cleveland to attend Middlesbrough FC home matches.

### **THE ROLE**

- Transport participants to events and sessions as and when required
- Drive Foundation vehicles to the highest possible standards
- Understand and support the health and safety and risk assessments needs of delivery as well as complex safeguarding requirements, raising any concerns with the appropriate Officers
- Ensure the bus is fit for usage by keeping it surface clean and carefully log and report all matters relating to vehicle upkeep, service and maintenance to Administration
- Operate the bus in a safe and efficient way according to legislation, policies and procedures

### **CANDIDATE REQUIREMENTS**

- Experience of driving a bus/coach
- Hold a valid driving licence, licensed to drive a minibus and have a D1 entitlement and Certificate of Professional Competence (CPC)
- A full clean driving licence with no more than 3 endorsement points
- Knowledge of Tees Valley
- Willingness to travel within the Tees Valley area and to support match days on occasion
- Excellent communication and customer service skills
- Knowledge of public safety and security
- A knowledge and understanding of good safeguarding practices
- Be flexible, punctual and friendly with a professional disposition
- Be eligible to work in the UK
